#### 2/12/84 THE EDDIE GRAHAM SPORTS STADIUM, ORLANDO, FLORIDA

- (1) Penny Mitchell & Despina Montagus W. Lei Lani Kai & Joel Martin (Mitchell pinned Kai with a well executed sunset flip cradle, off the ring ropes. During this match, there was alot of wild action. Both teams looked very good throughout the entire match.)
- (2) Kendo Nagasaki W. Dennis Brown (The end of this match occurred as follows Both men were fighting outside the ring on the arena floor. As this action was going on Kendo's Manager Jimmy Holiday, was on the outside ring apron distracting the referee. Finally, both men got back into the ring, to continue their fierce battle. Brown tried to ram Kendo into the ring corner, but The Oriental Giant was able to reverse it. Brown, then, fell to the mat floor. Kendo, then, gave Brown a knee to the chest area. Kendo, then, hooked Brown's legs for a pinning combination. During the match, Kendo used his mysterious green mist, that he blows from his mouth. This match had a lot of action, through and through. Brown looked good during this match, but Kendo looked great.)
- (3) Hacksaw (Jim) Duggan & The One Man GangeW. Joe Lightfoot & Mike Davis (Duggan pinned Davis, after The Gang gave Davis a foot to the upper chest/throat area.)
- (4) Hector Guerrero W. Joe Lightfoot (This match started off with a bang. Hector was originally, to fight Mike Graham, but the ring announcer, Bruce Tharpe, announced that Mike could not make it to the arena, because he could not get a plane out of Atlanta, Georgia. This announcement made Hector very mad. He was standing in the ring with no opponent. Hector, then, got hold of the microphone and said a few choice words about Mike. He, then, challenged anybody in the building, to fight him. Joe Lightfoot came running from the dressing room, to accept his challange. During this match, each athlete tried everything he could think of, to down the other. The finale came, when Joe tried a roll over pin, but Guerrero was able to reverse it, and pin Lightfoot. When the decision was announced, that Guerrero was the winner, Joe got very upset, and went wild. Joe threw Hector to the ring ropes. Guerrero, then, came off the ropes, and Joe gave him a chop to the upper chest/throat area. Both men looked extremly good in this very rough battle.)
- (4) Mike Rotundo W. Black Bart (Texas Bunkhouse Match: Mike won this match, by pinning Bart, after a well executed sunset flip cradle, off the ring ropes.

During the match, Bart was bleeding from his forehead. Both men looked very good in mat action)

- (5) Bill Jack W. Kharma -DQ. (The end of this match occurred as follows: Kevin Sullivan who was outside the ring, during the match, came up to the outside ring apron and tried to throw salt into Bill's eyes, but missed. The salt, instead, landed in Kharma's eyes. The referee seeing this action, signaled for the bell and disqualified Kharma for outside interference. After the match ended, Billy got a hold of Sullivan. Billy, then, executed a swinging full nelson, and put a lot of pressure on the hold. The referee could not stop this action. A few wrestlers came running from the dressing room, to help the referee break up this wild mess. This match had a lot of action, with Billy showing Sullivan and Kharma who the boss really is.)
- (6) Ron Bass W. Barry Windham -C.O.R. (This match started off fast and furious. Barry gave Ron a couple of dropkicks, sending Bass to the arena floor. During the match, Windham gave Bass a body slam and three atomic knee drops, in a row, sending Bass to the mat floor. During the match, both Bass and Windham were fighting on the arena floor. Bass, during this wild encounter, executed a very good pile driver and a forearm, to the back of the head. Bass and Windham left the ring again, and fought on the arena floor. Bass threw Windham into the wooden barrier, head first. Barry started to bleed very badly from this action. Windham, finally, regained his composure, and let Bass have it. They, finally, both entered the ring, and went at it like wild tigers. Windham came off the ring ropes, and flew over Bass. Windham, by doing this action, knocked the referee out of the ring. Bass and Windham still went at it. Black Bart came running from the dressing room into the ring, and hit Barry with his boot. He then went back to the dressing room. Windham, after being struck by Bart's boot, fell out of the ring, onto the arena floor. At this point, the referee had gained his composure, and counted Windham out, outside of the ring. Another referee came into the ring, to tell the first referee what had transpired, while he was knocked out of the ring. While the two referees were talking, Barry executed a sunset flip cradle, off the ring ropes. One of the referees, seeing this, took the three count. Everybody in the arena, including Barry, thought he won the match and The Southern Heaveyweight Title. Barry left the ring with the belt. Right after he left the ring, the referee raised Ron's hands in a token of victory. The next morning, in the newspaper, the result read that Bass won the match on a count out. This match had a lot of action in it with both athletes looking very good. In the opinion of this writer this was one of the strangest endings I have ever witnessed in the years I have been following this great sport of wrestling.)

2/15/84 THE TAMPA SPORTATORIUM, THE HOME OF CHAMPIONSHIP WRESTLING FROM FLORIDA (TV TAPINGS, MORNING)

#### FIRST HOUR:

Gordon Solie interviewed Kevin Sullivan and Kharma
Kevin Sullivan W. Mike Allen (By pin, with a shoulder breaker.)
Barry Windham W. Marvin Turner (By pin, with a clothesline.)
Gordon interviewed Barry Windham and Dusty Rhodes
Joe Lightfoot W. Kendo Nagasaki -DQ. (Kendo was disqualified for hitting Joe in the throat. Billy Jack came out to help Joe, but was struck repeatedly by Nagasaki, with his kendo stick. Other wrestlers came out to help Billy and Joe back to the dressing room.)
Hacksaw Duggan W. Ron Sexton (Duggan went into the ropes, and held onto it. Sexton tried to drop kick Duggan and missed. Sexton fell to the mat floor. Ron then got up, dazed, not knowing what happened. Duggan seeing that his opponent was dazed, wasted no time, and used a football block on Ron, and

Mike Rotundo & Barry Windham W. Ron Bass & Black Bart (Bart threw Windham out of the ring. At the same time, Bass and Rotundo were slugging it out by the corner turnbuckle. Barry, finally regained his composure, and came into the ring. He gave Bart a clothesline. He, then, pinned Bart.)
Kharma & The One Man Gang W. Dennis Brown & Mike Fever (Karma pinned Fever, after the use of a neck breaker.)

The One Man Gang W. Tony Diamato (By pin, after a knee to the chest and a big splash.) Black Bart W. Ron Sexton (Ron threw Bart into the corner turnbuckle. Ron then tried to ram him, but could not. Bart, then, caught Ron and body slammed him. He, then, gave Ron a pile driver, and then pinned him.) Mike Rotundo W. Marvin Turner (By pin, with an airplane spin.) Barbara Clary interviewed Les Thornton on her Take Five Segment of the show. Les Thornton DREW Mike Davis (This match had alot of action. The match was stopped by the referee, when television time ran out.)

Both teams looked superb in mat action) Ron Bass DREW Mike Rotundo (During the match, both athletes tried everything in their power to down the other. The finale of this action packed match occurred as follows: Rotundo had bass in an airplane spin. Mike, then, went for a pinning combination. While the referee was taking the pin count, the bell rang to signal the end of the match. The bell rang before the referee finished his count. The official announcement stated that this match was a time limit draw. Both Ron and Mike looked in very good shape throughout the entire match.

Dusty Rhodes & Billy Jack W. Kevin Sullivan & Kharma (Texas Tornado Match) (Billy picked up Dusty and dropped him on top of Kharma. Rhodes, then, hooked Kharma's legs for a pinning combination. Both teams looked very good in mat combat.)

Ric Flair W. Barry Windham -DQ. (This match had alot of action, with both men giving it their all, to try and do the other in. During the match, Flair and Windham were fighting outside the ring, on the arena floor. Both Flair and Windham were bleeding very badly from their foreheads. The referee had a very hard time controlling these two men. The finale came, when Barry knocked the referee down. When the official regained his composure, he signaled for the bell and disqualified barry for knocking him down. Ric may have won this match on a disqualification, but nevertheless, it was a proud victory.)

I missed the first two matches because of delay in travel from Tampa where I saw the TV tapings that morning.

Thile I was in florida I attended three fantastic cards. I saw several champions in action. Nobody's laughing today. The NWA, beset wit's the losses of Flair's two leading challengers (Lex Luger and Sting) to legitimate knee injuries. needed a new challenger for Flair.

Ole Anderson, who was named booker for the group earlier this month, decided the way to turn around the fortunes of the red-ink laden promotion was to bring back names from years past.

To the shock of nearly everyone, the prime focus of Anderson's ideas was to resurrect JYD. Dog, 38, pinned Flair in a few nontitle end. This set

Junkyard Dog, from a line in an old Jim Croce song, was given to Sylvester Ritter by Louisiana promoter Bill Watts in 1979. The Dog's star skyrocketed that year, when he headlined several shows at the Superdome in New Orleans that drew more than 20.000 fans. At 6-foot-21/2 and 260 pounds, and with a body like granite. he looked and could talk the sport.

Though the Dog couldn't wrestie the part. Watts hid that by mainly putting him in the ring with the best wrestlers in his area.

When Vince McMahon started his national expansion of the World Wrestling Federation in 1984, JYD was one of the first men he went after. The Dog became an instant star and was earning upwards of \$250,000 per year.

Approaching 280 pounds, his live and philosophizing interviews turned into barking when McMahon changed his character. For a time he trailed only Hulk Hogan as McMahon's top "baby face" (good guy) attraction.

But the Dog had a problem with showing up for his matches. This led to his being fired for the first time by the WWF in 1987. McMahon gave him a second third and fourth chance, but his no-show and weight problems didn't improve. His popularity and drawing power had waned badly, and by 1988, the once-unbeatable superhero was losing opening matches to the likes of Ron Bass. By autumn, he was let go for the final time.

The NWA tried to revive his career. But all the problems that had killed him in the WWF remained. The draw should have been

ALSO TAPING THE ENTIRE NIGHT OF WILD ACTION WAS KMGH-TV, CHANNEL 7 IN DENVER. THEY WILL BE DOING A FEATURE ON RMWA!

THE OPENING EVENT BETWEEN THE MASKED AIRBORNE RANGER AND TOO COLD SCORPIO SAW BOTH MEN FLYING BUT THE POPULAR SCORPIO WAS THE VICTOR. SCORPIO DID A FLYING ROLL OVER THE ROPES AND A PRESS TO MAKE THE PIN.

MAKING HIS RMWA DEBUT WAS U.S. JUNIOR HEAVYWEIGHT CHAMPION, "THE PRINCE" RIC McCORD. HE FACED DOUG "BLACK MAGIC" MASTERS IN AN EXCELLENT MATCH THAT WAS FAST PACED. WRESTLER TED NALL CAME TO AID MASTERS AFTER HE HAD BEEN DROPKICKED OUTSIDE THE RING AND HELPED DOUG INSIDE.

NALL CONTINUED TO STAY AT RINGSIDE AND TRIPPED MCCORD COMING OFF THE ROPES. MASTERS MADE THE PIN. HOWEVER, JERRY STEVENS WHO WAS SITTING AT THE RINGSIDE TABLE, GOT INTO THE RING AND EXPLAINED TO REFEREE JEFF SLADEN WHAT HAPPENED.

SLADEN THEN EXTENDED THE MATCH DUE TO THE INTERFERENCE BY NALL. RIC MC-CORD CAME BACK TO WIN USING A CRADLE! THEN NAIL AND MASTERS DOUBLE TEAMED MCCORD. STEVENS RUSHED TO HELP RIC.

JERRY CHALLENGED NALL AND MASTERS WITH MCCORD AS HIS PARTNER TO A MATCH IMMEDIATELY. THE FOUR RETURNED LATER ON.

THE PREDATOR GOT THE BEST OF DON JUAN (WITH VALET TERRY) IN A ROUGH AND TUMBLE MATCH. PREDATOR WON WITH THE SUPLEX AND PRESS. DON JUAN WAS QUITE UPSET AT THE VERDICT AND ARGUED WITH REFEREE STEVE HARMS. WHEN DON PUSHED THE REFEREE REPEATEDLY, HARMS HAULED OFF AND FLOORED HIM. VALET TERRY PUT HER TWO CENTS IN AND ENDED UP GETTING SLAPPED ON THE REAR BY HARMS WHO LEFT THE RING!

BY POPULAR DEMAND, THOSE EXTREMELY PLEASING RMWA FAVORITES RETURNED - THE MIDGETS! LITTLE TOKYO HAS GAINED A FOLLOWING AMONG RMWA FANS REGARDLESS OF HIS RING TACTICS. HE COULDN'T GET THE BEST OF COWBOY JIMMY COTTRELL. THE CUTE COWBOY WON WITH HIS BULLDOG SLAM AND PRESS.

PROVING A TOP COMBO, JERRY STEVENS AND RIC MCCORD FACED TED NALL AND DOUG MASTERS. THIS WAS TOP ACTION. IN A BEAUTIFUL MOVE, AT THE EXACT TIME, JERRY AND RIC USED ROLLING CRADLES TO WIN THE MATCH IN A DOUBLE COUNT PIN. JERRY PINNED NALL WITH RIC PINNING MASTERS.

"THE PRINCE" WAS THEN TOSSED FROM THE RING ONTO THE FLOOR. STEVENS GOT DOUBLE TEAMED BEFORE THINGS WERE BACK IN ORDER AND ALL FOUR WRESTLERS SENT TO THE LOCKER ROOM.

THE LONG AWAITED MAIN EVENT ENDED THE EVENING. THIS WAS A NON-SANCTIONED MATCH BY RMWA - A TEXAS BULLROPE MATCH BETWEEN BARRY O AND RIVAL RANDY RHODES. YOU HAD TO BE HERE TO BELIEVE IT.

FANS WILL BE TALKING ABOUT THIS MATCH FOR A LONG TIME! IT WAS THE BLOODIEST MATCH I HAVE SEEN SINCE A CHAIN MATCH BETWEEN GREAT MALENKO AND RONNIE GARVIN AT KNOXVILLE, TENNESSEE IN 1978!

BOTH MEN WERE BLEEDING PROFUSELY. THERE WERE POOLS OF BLOOD ALL OVER THE CANVAS (NOT TO MENTION THE LOCKER ROOM AREA LATER!) THEY FOUGHT INSIDE AND OUTSIDE THE RING.

THIS WAS A NO DISQUALIFICATION MATCH. HOWEVER, REFEREE STEVE HARMS FEARING SOMEONE WAS BLEEDING TO DEATH STOPPED THE MATCH! BARRY O'S FRIEND STEVE REGAL RACED TO THE RING HELPING BARRY CONTINUE HIS ATTACK ON THE PRONED RHODES.

Picture Vince McMahon and Ted Furner grappling somewhere between the Civic Arena and the A.J. Palumbo Center on Duquesne University's campus to determine who will win title to the area's grappling fans and that's what we have in store for us next month.

Both the World Wrestling Federation and National Wrestling Alliance have scheduled shows within an eight-day period in June. And both are "A" cards.

Turner's NWA will stage a card featuring a Lex Luger-Ric Flair main event on June 1 at 8 p.m. at Palumbo Center. McMahon's WWF comes to town with Rick Rude vs. Ultimate Warrior as headliner on June 9 at 8 p.m. at the Arena.

Next month's WWF event was announced during last weekend's show to the more than 9,000 fans who attended the card, which was opped by Earthquake's victory over 'Hacksaw'' Jim Duggan.

The next day, the NWA revealed its Palumbo plans during its syndicated TV programs. Its last appearance here was at the Civic Arena turing the Great American Bash tour last summer.

Local wrestling fans only can win during such a battle of the big romoters, but what remains to be seen is if the area can support monthly appearances by both. The NWA is following its strategy of booking small arenas and shouldn't have a hard time filling the Palumbo Center.

The WWF, however hasn't filled the Arena since Hulk Hogan's last appearances here and hasn't come close to a sellout since local favorite Bruno Sammartino donned the tights. The NWA packed a good crowd into the Arena a couple years ago for the Bunkhouse Stampede

cage match final between Dusty Rhodes and Big Bubba Rogers, alias Big Boss Man.

The June 1 NWA program also includes a Road Warriors-Doom match, Rick Steiner against Barry Windham and Abdullah the Butcher vs. Bam Bam Bigelow.

Also on the June 9 WWF card are "Mr. Perfect" Kurt Hennig vs. Brutus "the Barber" Beefcake; Rhythm and Blues, Honky Tonk Man and Greg "the Hammer" Valentine, faces Luke and Butch of the Bushwhackers; Barbarian vs. "Superfly" Jimmy Snuka; Dino Bravo opposes Tito Santana, and Akeem vs. Hercules Hernandez.

Beefcake defeated Hennig's companion, "The Genius" Lanny Poffo, with a sleeper hold at last weekend's show. He proceeded to give Poffo a haircut and pull off his wig that was covering the damage from the last trim Beefcake administered at Wrestlemania.

Hernandez lost to "The Model' Rick Martel after Martel reversed a pin attempt by Hernandez after a powerslam and grabbed a handful of tights to aid the cover.

Best match on last Friday's card was the tag team title tilt between champions Demolition and the Hart Foundation, which ended in a double disqualification and a long afterbout brawl between the two teams that included several wrestlers from the dressing room who ran to the ring to "help break up the battle" after the bell rang.

IN OTHER LEAGUES — "The Russian Nightmare" Nikita Koloff is prime challenger for Larry Zbyszko's AWA world title belt. Fanfavorite Koloff now wears both the U.S. and USSR flags on the back of his warmup jacket.

Zbyszko, who briefly Jost the title to Mr. Saito, will defend his belt on TV against The Trooper on AWA "Championship Wrestling" May 21 at 4 p.m. on ESPN. The Destruction Crew, Mean Mike Enos and Wayne "The Train" Bloom, continue to defend the AWA tag team belts while they fulfill their masked roles as Minnesota Wrecking Crew II in the NWA.

USWA matchmakers have come up with yet another type of bout: the Eight-Man Texas Tornado Tough Man Contest, which aired on last weekend's USWA telecasts. The match consisted of Eric Emery, Jeff Jarrett, Bill "Superstar" Dundee and manager Percy Pringle on one side, and Gary Young, Jeff Gaylord, Steve Austin and manager Scandar Akbar on the other team.

The match starts as a normal eight-man tag match, but after each pinfall the winning team can designate a member of the opposing squad to step into the ring to get the heck beat out of him by all four opponents for 60 seconds. After one minute is up, if the victim cannot answer a 10-count his team loses the match.

The team of Emery, Jarrett, Dundee and Pringle won after Akbar was counted out.

NO MORE, DUDES — Shane Douglas has left the NWA, thus breaking up the Dynamic Dudes tag team. Ex-partner Johnny Ace remains as a singles grappler. Eddie Gilbert and Tommy Rich will replace the Dudes in the Capital Combat match against Samoan Swat Team. Ace remains on the card and will face Mean Mark Callous. Douglas apparently left the NWA after becoming dissatisfied with his current status and thought he should be given higher billing.
