Johnny pinned Sonny with his foot on the ropes. This gets an 8.)

Frank The Tank Nelson W. Cody Hunter (Frank used a good dropkick. Cody's Manager started to call Nelson a Moron. The fans started to call Cody "Chubby Bubbles". Ken Patera W. Captain Fantastic (Patera pinned Fantastic in twelve seconds. This match gets a 2.)



Word, however, has leaked that Slaughter, the one-time GI Joe spokesman turned U.S. traitor, will get ambushed by Gen. Adnan and Col. Mustafa during their colossal jostle with Hulk Hogan and War-

Slaughter, who is really Bob Remus in civilian attire, is apparently fed up with his villainous role and demanded a change. The powers that be with the WWF have apparently relented.

Slaughter, who was being groomed as the WWF's kingpin prior to the emergence of the Hulkster in the early '80s, left the organization following a bitter dispute with boss Vince McMahon.

Slaughter returned earlier this year and essentially bowed to every demand made by McMahon, who forged the pro-tragi association

who forged the pro-Iraqi association.

If anything, Slaughter is considerably richer in his second WWF incarnation.

Ric Flair remains a very confused wrestling superstar without portfolio.

The Nature Boy has been contacted by the WWF after being fired by the WCW. Flair, 40, is faced with an unusual problem—he would like to continue, but he hates the WWF. In the end, the WWF's riches should be enough to entice Flair.

# WWF grapples with drug problem

NEW YORK (AP) — World Wrestling Federation boss Vince McMahon has acmitted using steroids he received from Or. George Zahorian, who was convicted ast month of illegally selling the drugs. "I used a steroid that I got from Dr. Zahonan very briefly about 3½ or four years ago," said McMahon, who is not a wrestler but does do some bodybuilding. IdcMahon made the statement at a news conference yesterday to answer conference yesterday to answer allegations that the WWF is rife with steroid use.

## WRESTLING / WWF king admits use

WRESTLING / WWF king admits use

Norld-Wrestling Federation owner Vince McMahon admitted to having used steroids that he received from Dr. George T. Zahorlan III, who was convicted last month of illegally selling the body building drugs.

"I used a steroid that I got from Dr. Zahorian very briefly about 3½ or 4 years ago," said McMahon, who is not a wrestler himself but does do some body building. He used the steroid only once, he said.

McMahon made the admission at a news conference yesterday to answer allegations that the WWF is rife with steroid use Zahorian said he sold steroids to various wrestlers, including WWF champion Hulk Hogan and Rowdy Flocky Piper.

Eearlier this month, the WWF said it would begin including steroids in the weekly drug testing it has done since 1987. McMahon said the WWF would be able to announce some specifics of the plans "very, very soon."
