FOOD REPORT: Not having the pizza for a long time, I decided to see if it returned back to the original accolades of previous years. It came close. The size was larger, about 4" by 6" square. The cheese and pepperoni were plentiful and the dough was crisp and fresh. The only drawback was the hot lights heating element to keep the pizza warm. It really does not do the trick and makes the pizza greasy. If the Arena would only make the pizza the way they used to, in the Pizza Hut conveyor belt manner, will it reach its original luster. At the souvenir stand, new items for sale were an unispiring \$16 Bulldog T-shirt and a four photo color of the Ultimate Warrior of the same pose done psychedelic style that didn't catch my fancy. However, the \$8 Big Bossman sunglasses looked to be of decent quality and would certainly be a prized item for someone not needing prescription eyeware. Before entering the Arena, there were several signs declaring Ultimate Warrior was injured and that Randy Savage would be replacing him. Also, the ring announcer stated Mr. Perfect and Shawn Michaels were injured and that anyone wishing a refund could do so prior to the completion of the first matchup. Titan showed its class and honesty again. The Irresistible One joined us and started the ball rolling with this joke: "What's the difference between a superior whitewall and 350 used condoms?" ANSWER:-The former is a Good Year and the latter is a Great Year!! Ha! Get it? Now, promoted by Titan Sports, onto the matches:

- (3) COLOURL MUSTAFA with GENERAL ADNAH pinned KOKO B. WARE at 13:11.

 * (D) * Horrible match. The highlight was Mustafa's Pearl Harbor job while Koko was depositing Frankie at the corner. After the quick recovery by Koko, they didn't lock up again until 6:18. Koko reversed a

suplex at 12:12 and went on a tear until he missed on a charge into the turnbuckles that enabled Mustafa to feebly cover him for the pin.

(4) HOUNTIE & MASTY POYS with JIMMY HART beat THE LEGION OF DOOM & BIG BOSSMAN in a Six-Man at 14:12. HOUNTIE pinned BOSSMAN. * (B) * Knobbs ripped up a fan's L.O.D. poster and threw it on Hawk and mass mayhem developed and the heels fled to the dressing room. Bossman caught the leapfrogging Mountie and slammed him hard to the mat at 3:33. Fans went bonkers. Mountie then got pressed by Hawk who heaved him onto both Nasties at 8:37. Animal got the tripleteam shortly afterwards until Bossman got the hot tag at 13:24 and the match broke down. During the melee, Mountie grabbed the cattleprod to zap and whack Bossman on the noggin for the pin. Good show.

(5) SERGEAUT SLAUGHTER with GENERAL ADNAN beat HACKSAV JIM DUGGAN by DO at 15:33. • (C-) • The One grabbed a newspaper, held it sideways and questioned Duggan with: "Hey Hacksaw! Is this how you read the paper?" and Duggan smiled, pressed his fingers and asked The One and his evening mate, The Educated Man: "Are you guys lovers?" to which The One and the Educated Man responded by standing up in unison and hugging each other. Besides myself, ref Earl Hebner lost it as we all cracked up. Hebner did a nice routine with Sarge that left Sarge on the mat from a hip toss by Hebner. One of the contestants bumped Hebner around 14:00 and Sarge grabbed the 2 by 4 and started hitting Hebner on the back with it. Hacksaw got the board just as Hebner revived himself to get Duggan disqualified. Hebner was the star that made the match a decent one. Jannetty went most of the way getting doubleteamed and recovering without tagging in Douglas for long periods. Douglas slugged Tanaka at the ropes to give Jannetty a cheap schoolboy pin.



Savage caught fire and finished off Undertaker with the urn to get Undertaker stuffed into the body bag.

Steroids Issue Outshines Matches

Some members of the professional wrestling scene are trying to take the current steroids scandal and turn it around in their favor.

During a week that read like a True Confessions magazine, WWF World champion Hulk Hogan denied using illegal steroids to build up his body but says he took a male hormone to treat muscle injuries.

And WWF owner Vince McMahon admitted to having used steroids that he received from Dr. George T. Zahorian III, who was convicted last month of illegally selling the body-

building drugs.
"I trained 20 years, two hours a day to look like I do," said Hogan, 37, who holds the WWF title for the third time. "I am not a steroids." abuser and I do not use steroids.'

Hogan appeared on Tuesday's "The Arsenio Hall Show" — at his own request, according to Hall and stayed out of his ring character for the entire interview.

Hogan said he used the hormone, which he didn't identify, as part of a physical therapy regimen that included ultrasound treatments, deep muscle massage and prescribed

drugs.
"This involved basic anti-inflam-

matories and a synthetic male hormone which is a steroid," he said.

A torn biceps suffered during a match in 1983 forced Hogan to decide between surgury and sports therapy which included persecitives. therapy, which included perscription drugs. Surgery would have forced Hogan to stay out of action for several months, he said, which he could not afford to do at the time. He said he was wrestling about 300 bouts a year at that point.
At a federal trial in Harrisburg,

Zahorian testified he sold steroids to several pro wrestlers, including Hogan. Zahorian was convicted of illegally selling the body-building drugs.

Hogan said he was upset by the steroids trial and the "lies in the courtroom that were taken as fact. . It hurt me, it hurt my family. It put a dark cloud over what I believe in.''

McMahon made the admission of his steroids use at a news confer-

ence Tuesday to answer allegations that the WWF is rife with steroid

use.
"I used a steroid that I get from hriefly about Dr. Zahorian very briefly about three and a half or four years ago," said McMahon, who is not a wrestler himself but does do some body building. He used the steroid only once, he said.

Zahorian said he sold steroids to various wrestlers, including WWF champion Hulk Hogan and Rowdy Roddy Piper.

This affords us the opportunity to answer some allegations, however outlandish, and also is a day on which we can make a promise - that we will be held accountable." McMahon said.

Earlier this month, the WWF said it would begin including steroids in the weekly drug testing it has dore since 1987. McMahon said the WWP would be able to announce some specifics of the plans "very, very soon.

McMahon also said he soon would no longer be overseeing the drug testing himself, and that it would be turned over to an independent com-

At the same time, McMahon said that while there have been instances of drug abuse among WWF wres-tlers, it is much less prevalent than has been charged.

"People have been taking the word of individuals who are not credible, and that's irresponsible, in my opinion." McMahor said. "... We never want anyone again to question whether this is good, wholesome entertainment."

"The WWF wants to stay in the headlines." Hogan said. "We look at this as a positive We're going to be the role models for all of the other athletes. I wish the NFL would adopt Vince McMahon's drug test policy."

He also termed former WWWF World champion Brune Sammartine a hypocrite for criticizing steroids use after working with wrestlers such as Superstar Billy Graham, who admitted his abuse of steroids in the 1970s resulted in hip replacement surgery, ankle problems, liver

Last weekend's WCW Great American Bash pay-per-view turned out to be quite uneventful. Matches were dull, announcing was bland, and the pace of the show lacked excitement.

Will Justice Be Blind to Favorites?

Pro wrestling is rich with symbolism. Many times a wrestler's name itself will indicate to fans the role he will play in the ring before he steps through the ropes.

Consider the case of Sid Justice, who came to the WWF this summer from WCW, where he was known as Sid Vicious and was one-fourth of the Four Horsemen.

Short clips of Justice have been played during WWF telecasts for several weeks, and the reaction from some of the promotion's other performers made it dificult to tell if Justice would be cast in the role of a good guy or bad guy.

Last week, Justice was announced as special guest referee for the three-on-two "match from hell" on the Aug. 26 SummerSlam '91 payper-view card. Justice made it clear during an interview on the weekend syndicated programs that he will not side with the competitors on one team that consists of Sgt. Slaughter, Col. Mustafa (aka Iron Shiek) and Gen. Adnan.

But does that mean he will throw his allegiance behind the opposition — WWF World champ Hulk Hogan and Ultimate Warrior? Or will we see a rarity in the ring wars — a special guest ref/wrestler who will act impartial?

Hogan and Warrior, who will headline next Friday's WWF card at Pittsburgh's Civic Arena in a body bag match against the Undertaker, are almost certain to show up on a live interview segment on this weekend's telecasts to promote their SummerSlam match.

Also likely to appear on the programs is Justice, who either will hint to his backing of the fan favorites or again state his intention to be

an impartial arbiter for the main event at SummerSlam, which will be staged at New York's Madison Square Garden and will mark the first return of a WWF supercard to that facility since the original WrestleMania in 1985.

Eventually, Justice will be made to choose a side, whether it is at SummerSlam or later this year. If Justice was brought to the promotion by WWF czar Vince McMahon with the promise of the main event at WrestleMania VIII, i means he will turn rulebreaker b enable a Hogan-Justice match of we might see a favorite-vs.-favorite contest similar to Hogan-Warrior at 'Mania VI.

But why let the cat ou of the bag now? Why not keep everyone guessing for a while? Letting Justice play it down the middle for the entire SummerSlam event and cardtopper match will increase fans' tension and speculation on which way he eventually will lean.

Next Friday's Pittshirgh main event between Warrior and Undertaker was spurred by the pair's last match at the Civic Aena, when Undertaker ended up stiffing Warrior into a body bag during a match that didn't contain a stipulation for use of the object.

But don't look for the match to have any bearing on the Summer-Slam main event, such as many arena matches have been used to set up pay-per-view events. The Warrior-Undertaker feud has reached its end and next Friday's tilt will serve as its climax.

Also on the Civic Arena card is a six-man tag bout pitting Big Boss Man and Legion of Doom against the Mountie and WWF World tag

team titleholders Nasty Boys. Although no such match has been announced for SummerSlam, this six-man match might point toward the long-awaited title shot for the LOD against the Nasty Boys at which time Animal and Hawk capture the title.

Another bout resulting from the last Pittsburgh card will match Intercontinental champion Curt Hennig against Davey Boy Smith. Last time the pair grappled till the 20-minute time limit expired, so this match will have a one-hour limit. But remember, this is the WWF, so there is no chance both men will be in the ring for 60 minutes. Even a 30-minute match is remote.

At SummerSlam, Hennig will oppose Bret Hart in a match that will feature the two best technical wrestlers in the federation today. Hennig also takes the best fall of any current WWF performer.

Also on the Civic Arena card: Hacksaw Jim Duggas vs. Sgt. Slaughter, Kerry Von Erich vs. Barbarian, Rockers vs. Orient Express, and Koko B. Ware vs. Col. Mustafa.

The remaining three cards this year at the Civic Arena are scheduled Sept. 20, Nov. I and Dec. 15. All are Friday night events.

Also announced for SummerSlam are the Bushwhackers (with Andre and Giant in their corner) against the newly formed Natural Disasters, Earthquake and Typhoon (formerly Tugboat). Another bout will pit Ted DiBase against ex-bodyquard Virgil.

Bruno-Hulk: wrestling legends wage war of words



Bruno Sammartino Down on steroids

"To say I was a hypocrite for getting paid to wrestle Billy Graham is ridiculous," Sammartino said this week. "How can he suggest I'm responsible for someone else's behavior? I'm responsible for my own.

"I'd heard Hogan was going to come clean on 'Arsenio,' admit he'd taken steroids. Instead, it was almost total denial. And he calls me a hypocrite? That jerk's been on that stuff so long ... For him to come on TV wearing a cross and just tell lie after lie — it's ridiculous."

OK, so Sammartino's no Hulkamaniac. He's no fan of the WWF, either, which he left for good in 1988 after a 3½-year stint as a television commmentator.

He scoffs at announced WWEplans to institute steroid testing for its wrestlers. Besides Hogan, several other WWF wrestlers were implicated as steroid abusers at the Zahorian trial. Sammartino says "90 percent" of WWF grapplers use steroids.

"I don't believe they're going to have legitimate testing for steroids," Sammartino said. "They're saying that to please the media. No way they'll do it. They're just buying time and hoping the problem will go away."

WWF media spokesman Steve Plenamenta, after turning down a Post-Gazette request for a Hogan interview, said that the WWF steroidtesting plan was indeed legitimate.

""We want to get our [testing] trogram up and running as soon as cossible," Plenamenta said. "We've nterviewed two firms about conducting our testing. We wouldn't go brough the motions of doing that if this wasn't legitimate. We want to be on the right side of the law."

Wrestling Observer Newsletter editor Dave Meltzer took Sammartino's side in the dispute.

"For Hulk Hogan to call Bruno Sammartino a hypocrite is ridicutious." Meltzer said. "Hogan's done what he accuses Bruno of doing—making money off wrestling someone that takes steroids—50 times over.

It's a pro wrestling dream feud: Ross Township resident Bruno Sammartino vs. Hulk Hogan.

And, even though it's being fought with words, not holds, the two biggest names in the history of the World Wrestling Federation are waging a very lively battle indeed.

very lively battle indeed.

Ex-WWF champion Sammartino, 55, has long been outspoken concerning steroid abuse in pro wrestling. Current champ Hogan, 37, has faced the media's (and Sammartino's) wrath since it was revealed that he bought steroids from a Harrisburg physican, Dr. George T. Zahorian III.

Zahorian was convicted on eight counts of selling steroids for nontherapeutic purposes at his trial earlier this month.

At his trial, Zaherian testified that Hogan was a heavy steroid user between 1984-89. Hogan testified differently on the "Arsenio Hall" television show last week.

Hogan said that he'd only taken steroids three times, each time to heal injuries. He criticized Sammartino, calling him a "hypocrite" and accusing him of "using Superstar Billy Graham to put money in his pocket."

Former WWF champ Graham, 48, feuded with Sammartino in the 1970s. Graham has had a hip replacement and two ankle operations due to side effects from his admitted steroid abuse and now walks with the aid of a cane. He is also sterile and has been diagnosed as having liver problems.

"And for Bruno to speak out against steroids is legitimate — he never took them. For Hogan to do it on 'Arsenio' is absurd for obvious reasons."

You'd be hard-pressed to find anyone in wrestling who would accuse Bruno Sammartino of taking steroids. But he admits wrestling's steroid problem hit close to home once.

"My son David denies taking steroids, but there was a period of time when I was damn sure he was taking them," Bruno said. "I felt very heartbroken, very angry that my son would do something I was so against doing.

"But looking at David now, I do believe he's off them."

David Sammartino, 30, once wrestled in the WWF as well as in the National Wrestling Alliance. He lives in Georgia now and wrestles only sparingly.

Bruno hopes the WWF is sincere about eliminating steroids. But he hopes the public is prepared for some changes if it is.

"If the WWF eliminates steroids, we'll see a wrestling organization that looks like a basketball team," Sammartino said. "What do you think those guys are going to look like off that stuff, guys like [6-foot-9] Sid Justice?

"If they go completely clean, those guys will deflate so fast it'll shock people."
